Asbestos Analysts and Surveyors

Professionally Qualified Person



ATaC operates the AMI Skills Card Scheme, a nationally recognised construction skills card scheme carrying the CSCS logo.

All Partner Card Schemes are based on the same standards as CSCS, often requiring the card holder to gain a nationally recognised qualification and pass a Health and Safety Test. They might have additional requirements.

By carrying the CSCS logo these cards provide a means to verify identity and that the asbestos worker has the necessary qualifications, training and experience to carry out the type of work needed on a construction site.

All cards issued by ARCA use smart technology and contain an electronic chip which can be used to check the identity and qualifications of the card holder. When ARCA updates a holder's record, the chip in the card will automatically update.

A virtual smartcard is a smartcard stored in an app on the card holder's smartphone or tablet. Virtual smartcards can be issued to applicants in addition to the physical card at no additional cost if the applicant provides a personal mobile number and/or email address on the application form.
